



Memorandum of Understanding between Confederation of Young Leaders of India and National University of General San Martín

This Memorandum of Understanding (hereinafter, "MoU") is entered into by and between:

The Confederation of Young Leaders in India (hereinafter, "CYL"), located in B-85, Paryavaran Complex, South of Saket, New Delhi, India, represented by its Chairperson, Mr. Himadrish Suwan.

and

The National University of General San Martin (hereinafter, "UNSAM"), located in Av. 25 de Mayo y Francia, San Martín, Buenos Aires, Argentina, represented by its Rector, Accountant Carlos Greco.

Both CYL and UNSAM will be referred to individually as "Part" or "Institution" and collectively "Parties" or "Institutions".

Both CYL and UNSAM hereby provide a formal understanding of cooperation and friendship which purpose is to promote the academic goals of each Institution. Recognizing the mutual interest in fostering international cooperation in education, research, and youth engagement, both parties agree to collaborate in the areas of youth, scholars, and academic exchanges, as well as the promotion of distance learning diploma programs offered by the Indian Institute of Governance and Leadership (hereinafter, "IIGL") in Argentina, and vice versa, facilitating the expansion of UNSAM academic offerings in India.

The parties have agreed as follows:

- Establish a framework for cooperation between CYL and UNSAM in the field of education, research, and youth leadership development.
- Promote academic exchanges for students, scholars, and faculty between India and Argentina.
- Facilitate the joint promotion and delivery of diploma-level distance learning programs run by IIGL in Argentina and similar programs from UNSAM in India.
- Develop academic collaborations that ensure financial sustainability for both institutions.
- Encourage joint research projects, symposiums, conferences, and cultural exchange programs to strengthen academic and youth cooperation.

TERMS OF COOPERATION

 Terms of cooperations for each activity implemented under this MoU shall be discussed and agreed upon in writing by both parties before the beggining of activities. Any specific agreement which complies with the above mentioned process, will become an appendix to this MoU.





- 2. Each part shall appoint a designated coordinator from each institution to oversee the execution of this MoU.
- 3. This MoU does no imply any finantial duty. Each institution will be responsible for the search of necesary funding for financing its participation in the activities of cooperation contemplated in this MoU, which will depend on budgetary possibilities of the parties.
- 4. All activities shall be conducted within the framework of CYL and UNSAM internal rules and policies.

DURATION, RENEWAL AND AMENDMENT

- This MoU will be effective from the day on which it is signed by both universities and will have an initial validity of four years, subject to periodic revisions, may be extended expressly by the contracting parties by means of an agreement which must be formalised in writing before the expiry of the agreed period.
- 2. This agreement may be reviewed jointly and may be terminated by either party, provided that it is notified in writing twelve (12) months in advance, with the respective signature of the institution's representative. All amendments to this agreement must be in writing and signed by both parties.
- 3. It is the understanding of both parties that this Agreement is written in English and Spanish. In the event of any contradiction in the wording, the English version shall prevail over the Spanish version.
